In consideration of my engagement as a model, upon the terms herein stated, I grant the photographer, **Christopher M Carroll, (StudioCMC LLC)** his legal representatives and assigns, the absolute irrevocable and unrestricted right and permission to copyright and use, reuse and publish, and republish in any media any and all photographs taken by the photographer of myself, or in which I or an assisting photographer(s) may be included, for any purpose whatsoever, without restrictions as to changes or alterations from time to time for art, advertising, trade, or any other purpose whatsoever, and without further compensation to me.

All original negatives, positives, electronic files, will constitute the photographer's property, solely and completely. I hereby waive any right that I may have to inspect and approve the finished product or copy that may be used in connection with an image that the photographer has taken of me, or the use to which it may be applied. I further release the photographer, or others for whom he is acting, from any claims for remuneration associated with any form of damage, foreseen or unforeseen, associated with the proper commercial and/or artistic use of these images unless it can be shown that said reproduction was maliciously caused, produced and published for the sole purpose of subjecting me to conspicuous ridicule, scandal, reproach, scorn and indignity. The photographer agrees to use only the name or names specified by me in publication of the images taken and that no image of me will be intentionally used in a manner that can be considered libelous in any legal sense.

I hereby release, discharge, and agree to save harmless the photographer, his legal representatives or assigns, and all persons acting under his permission or authority or those for whom she is acting, from any liability by virtue of any blurring, distortion, alteration, optical illusion, or use in composite form, whether intentional or otherwise, that may occur or be produced in the taking of said images or in any subsequent processing thereof, as well as any publication thereof.

I (the model) understand that I may use the photographer's images for myself promotion and or personal use and only if the photographer's credit and copyright appear on the image. ***I do not have rights to grant nor conduct commercial sales of the images produced from this photography session unless that is agreed to in writing on this document.*** If I elect to use any images on the web, I agree to make a link to the photographer. I understand that I have the option to purchase additional rights to use these images in any manner I wish. I acknowledge that I understand that **No Editing or Photo manipulation/Digital manipulation shall be permitted, or is allowed to be done by the model, or any 3<sup>rd</sup> party artist, who was not present at the production of this Photography Session.** I am aware that I (the model) am **NOT** Permitted to self edit or attempt to hire or trade images to a 3<sup>rd</sup> party digital artist to perform artistic manipulations or any sort of Photoshop re-edit the final work under the terms of a TFI or TFCD Terms photography session. The Photographer will make good effort to repair any photographic flaws, or will remove blemishes at his behest, and within a reasonable time frame. I am permitted the option(s) to **purchase additional rights** to use, sell, and purchase the rights to edit these images in any manner I wish.
